1. APPOINTMENT OF CHAIRMAN

- 4. Apologies had been received from ex-officio trustee Rev Patricia Townshend, Vicar of St Peters Church, Dunchurch.
- 5. MINUTES

Minutes of the meeting held on Monday 30th September were approved and signed by Chair, Roland Robinson.

APPOINTMENT OF TRUSTEES

- a) Thurlaston Parish Council have confirmed the appointment of Jenny Cooper as a Parish Council appointed trustee for a term of 4 years.
- b) Jenny Cooper signed acceptance document to confirm she abides by the terms of the charity insurance policy.
- c) Sheena Ashford has been re-appointed as a trustee for a term of 5 years.
- d) Sheena Ashford signed acceptance document to confirm she abides by the terms of the charity insurance policy.
- e) There is still a vacant position for a Parish Council Trustee. It was advertised in the Village Chronicle but there was no response.
- 6. MATTERS ARISING
 - a) Ref 4b, 30 saplings are due to arrive in mid-March from Woodland Trust free of charge. Will be delivered to R Robinson, who will then plant them.
 - b) Ref 5b, bees have not yet arrived on the allotments. Likely to be May/June. C Camp has asked them to put a sign up to alert other allotment holders of their presence.
 - c) Ref 9, S Ashford has looked at the website and confirmed it is correct and that the grant application form has been added to it.
- 7. ALLOTMENTS

All usable allotments have been rented. All allotment holders are happy at present.

8. FARM LAND

a) R Robinson investigated current prices for farm land. He advised that current rate is around £360 - £380 per hectare for agricultural land. This works out at £150 per acre. Currently charging £100. Trustees agreed to increase the rent to £130 from 1st March 2021 and to then look at a further increase in 3 years. C Sabine to notify tenants of the increase by 1st March 2020 (in order to give 1 year's notice of increase.)
b) There were no other farm land matters to discuss currently.

c) The trustees signed the paperwork to add additional signatories to the cheque account.d) The Secretary reported that she had been late in banking rent cheques for the land rent.These have now been banked and invoices for the current 6 months sent to tenants.e) R Robinson agreed to arrange for the hedges to be cut. Invoice to be emailed to the Secretary for payment.

9. FINANCE

a) At 31.12.19 Thurlaston Poor's Plot Charity balance is £38,154.90 The financial statement was approved.
